A BRIEF RECENT HISTORY OF PUBLIC EDUCATION IN THE LEGISLATURE

- 2011 THE LEGISLATURE CUTS APPROXIMATELY \$5B FROM PUBLIC EDUCATION
- 2018 SEVERAL INCUMBENTS EKE OUT A WIN AGAINST OPPONENTS WHO RUN ON THE ISSUE OF PUBLIC EDUCATION.
 TEACHERS PLAYED A SIGNIFICANT ROLE IN THE ELECTIONS AND EVEN LT. GOV. PATRICK RECOGNIZED THIS POWER, PROPOSING AN ACROSS-THE-BOARD PAY RAISE IN THE FOLLOWING SESSION.
- 2019 HB 3 PASSES WHICH ADDS AROUND \$4B TO PUBLIC EDUCATION
 - NOTE THAT THIS "TRANSFORMATIVE" SCHOOL FINANCE BILL IS JUST SHORT OF RETURNING THE SCHOOL FINANCE SYSTEM BACK TO PRE-2011 AMOUNTS.
 - INTRODUCED THE TEACHER INCENTIVE ALLOTMENT
 - INCLUDED PROVISION THAT A CERTAIN AMOUNT OF THE INCREASE DISTRICTS GOT HAD TO GO TOWARDS TEACHER COMPENSATION
- 2020 INCUMBENTS RUN CAMPAIGNS ON THEIR VOTES FOR HB 3 AS A SIGNAL OF COMMITMENT TO PUBLIC EDUCATION.

2021 LEGISLATIVE SESSION

- BECAUSE OF HB 3, LEGISLATORS FELT LIKE THEY HAD DONE ENOUGH FOR PUBLIC EDUCATION AND THERE WAS NO NEED TO FOCUS ON IT
- SALARY AMENDMENT TCTA WORKED TO PASS AN AMENDMENT THAT WOULD GUARANTEE THAT SALARY INCREASES REQUIRED BY HB 3 WOULD BE MAINTAINED. EVEN GETTING THIS AMENDMENT PASSED WAS DIFFICULT, THOUGH WE WERE ULTIMATELY SUCCESSFUL.
- HB 3 CLEAN UP BILL INSTEAD OF PASSING ANOTHER SALARY INCREASE, THE LEGISLATURE INCREASED THE AMOUNT OF MONEY DEDICATED TO THE TIA AND CALLED THAT A PAY RAISE. APPROXIMATELY 3% OF TEACHERS HAVE EARNED DESIGNATIONS UNDER THE TIA.

2021 LEGISLATIVE SESSION CONT.

• FEDERAL FUNDS — BILLIONS OF DOLLARS IN FEDERAL FUNDS WERE DIRECTED TO DISTRICTS.

ORIGINALLY THE LEGISLATURE WORKED TO HAVE THAT MONEY SENT TO THE STATE BUT

EDUCATION ADVOCATES WORKED TO HAVE THAT MONEY SENT DIRECTLY TO DISTRICTS INSTEAD



 52% of voting age population (VAP) voted in general election.
 19% of VAP voted in primary election.

In 2018

 42% of VAP voted in general election. Less than 10% of VAP voted in primary election.

Sample Questions for Candidates

The last two years have left teachers frustrated, exhausted, and burned out. As a result, we expect a lot of resignations and retirements of experienced teachers at the end of the school year. What would you do to retain good teachers and advocate on their behalf?

What role do you think standardized testing should play in our accountability system, if any? Do you think teacher pay should be tied to student test scores?

Gov. Abbott has stated that the push for school vouchers will be stronger than ever during the 2023 legislative session. Do you support diverting public dollars to private schools? If so, do you think there should be academic accountability for the private schools that serve students with public dollars?

SPREAD THE WORD

- Tell friends/family, church acquaintances, neighbors... about teacher friendly candidates. Urge them to vote.
- Send emails about candidates' pro-public ed positions (use personal email account). Direct others to candidates' campaign websites.





- Use social media. Link to pro-public ed candidates' social media accounts. Comment positively on their social media and share their posts.
- Get local teachers excited & involved.
- Carpool to voting location.


